1. Key fob holders must abide by rules and regulations of LSPR or privileges may be revoked. No refunds are given for revoked memberships. Appeals may be made in writing to the facility manager.
2. Fobs may be acquired at any facility welcome desk during operating hours. The fobs remain the property of Lee's Summit Parks & Recreation and must be returned if requested.
3. Fobs/memberships cannot be transferred to others and should be on your person when entering LSPR facilities.
4. There is a \$1.00 replacement fee for lost, stolen or damaged fobs. No refunds for fob replacement fees.
5. Changes or cancellations must be made in writing on the Membership Cancellation/Change Request Form available at any of LSPR's facilities. Flex cancellations/changes must be submitted by the last business day of the month to take effect the following month. An in-person meeting with Facility Manager may be required
6. The 90 day membership option is non refundable.
7. There is a \$5.00 processing fee for any changes made to an existing Flex account.
